The Gem Bid notice no. 65 of 2025 dated 13-11-2025 issued vide No: WPJ/F-231/2020 dated: 13-11-2025. shall be governed by the below mentioned terms & conditions.

TERMS AND CONDITIONS OF BID

- 1. **Estimated Bid value**: The estimated tender value is Rs. 1.32 lac Approximately (Rupees One Lakh thirty two thousand only) including service charges and taxes for one year.
- 2. **Period of Contract:** The Contract shall initially be valid for a period of One year and may be extended further for a period of one year subject to satisfactory performance, on the same terms and conditions. The rates quoted by the bidder shall remain unchanged during the period of contract. Principal Govt. Polytechnic for Women Jammu, however, reserves the right to terminate the contract by serving one month's notice, in writing.
- 3. **Earnest Money Deposit (EMD)**: EMD amount of Rs. 2700/- to be deposited in the form of Demand Draft drawn in favour of "Principal Govt. Polytechnic for Women Jammu" payable at Jammu. The scanned copy of the same to be uploaded on GeM portal.
- 4. Firm registered under MSME will be exempted from EMD and Tender Processing Fee as per existing guidelines.
- 5. Last date of submission: Last date of uploading of Bid is stipulated on GeM portal.
- 6. **Date of opening of Bids:** Technical Bid will be opened on stipulated date and time on GeM portal.
- 7. **ELIGIBILITY**: Agencies having sufficient experience of providing Security Services Services in reputed organizations in Public Sector (Central Govt./State Govt./UT Govt/PSUs) for at least 02 (two) year in last 5 (Five) years immediately preceding the date of publishing of this tender.

Experience of having successfully completed similar works during last 02 years in last 05 years in which applications are invited should be either of the following: -

- a. One similar work of Annual value not less than Rs. 2.5 lac /- (Rupees Two Lakhs Fifty thousand only).
- b. Two similar works of Annual value not less than Rs.5 lac/- (Rupees Five Lac only).
- 8. The Agency must be registered with the following statutory bodies such as ESI, EPF, PSA (Regulation) Act, 2005 Income Tax and GST at least one year prior to publishing of this bid.
- 9. The average annual turnover of bidders must be duly certified by the appropriate Chartered Accountant/ Auditor/ any other prescribed authority and it should be minimum Rs. 5 lac/- (Rupees Five Lac Only) during each of the last three financial year (2022-23, 2023-24 and 2024-25).

10. The Bidder must have a registered office / Authorized office in UT of J &K.

- 10. The bidder firm should not have been indicted for any criminal, fraudulent or anti competition activity and not been blacklisted by any Government Departments.
- 11. Registration under Private Security Agencies (Regulation) Act, 2005 for Security Services is mandatory.
- 12. Only agencies having valid registration under contract Labor Act, ESI, EPF and other statutory law required for providing Security(Sweeper) services shall apply.
- 13. **Documents to be uploaded**: Bidders firms which fulfill the above eligibility conditions may upload the technical bid along with the scanned copy of following documents failing which their bids may be rejected:
 - i. Copy of Audited Accounts Statement of annual turnover for last three financial years (2022-23, 2023-24 and 2024-25)
 - ii. Registration / Incorporation Certificate of firm.
 - iii. Scanned copy of EMD, if applicable
 - iv. Registration Certificate of Contract Labor (Regulation & Abolition Act, 1970), Goods and Services Tax (GST), Employees' State Insurance Act, 1948, Employees Provident Fund Act, at least one year prior to the publishing of this bid.
 - v. Copies of satisfactory work performance report in support of eligibility conditions. Copies of work orders, agreements without Satisfactory Performance Certificate shall not be considered for determining the eligibility.
 - vi. Copy of PAN No.

- vii. Scanned Bid Document containing all terms and conditions of the bid duly signed and Stamped by the bidder.
- viii. Copy of registration certificate of shop and establishment for having Registered office / Authorized office in Jammu and Kashmir

The EMD must be submitted in the office of the Principal Govt. Polytechnic for Women Jammu in a sealed cover, before the last date and time of submission of Bid as per Gem Portal along with hardcopy of the documents uploaded on the portal. The tenderers qualifying in the technical bid will be allowed to submit financial bid on the GeM Portal.

- **14.** In case of more than one bidder quoting the lowest service charge in the financial bid, the preference for selection of eligible bidder shall be done as under:
 - i. The Bidder with maximum quantum (amount wise) of similar work completed during the last 3 years (February 2021 to till date) shall be preferred for award of work; if still there are more than one lowest bidder, then
 - ii. The average annual turnover during last three financial years (2022-23, 2023-24 and 2024-25) shall be compared and the bidder with highest average turnover in last three financial years shall be preferred for award of work.

OTHER TERMS AND CONDITIONS

Evaluation of technical and financial bid

- a. The Bidders are required to upload Technical bid as per Bid Specification uploaded on GEM Portal.
- b. Each and every page of attached document should be signed by bidder or the authorized representative of Bidders.
- c. Principal Govt. Polytechnic for Women Jammu reserves the right to reject all Bid in whole, or in part, without assigning any reason thereof.
- d. Lowest financial bid of those qualifying in the technical bid will be evaluated based on overall lowest rate quoted by the bidder.
- e. The earnest money shall be refunded to the unsuccessful Bidders after finalization of the contract. It shall be refunded to the successful Bidder on receipt of performance security deposit. No interest is payable on the EMD.
- f. The bid shall be valid for 90 days from the date of opening of financial bid.
- g. Bids which are incomplete or Conditional in any form shall be rejected out rightly.
- h. In case the successful Bidder declines the offer of Contract, for whatsoever reason(s), their EMD shall be forfeited.
- i. A formal contract shall be executed/ entered into with the successful Bidder. In this contract, the successful Bidder shall be defined as Contractor.

Performance Security Deposit

The successful Bidder will have to deposit a Performance Security Deposit of the financial bid as per Bid Details on GEM in the form of Demand Draft in favor of

GENERAL CONDITIONS OF CONTRACT (GCC)

- 1. The Agency should engage the Security Personnel with age not more than **60 years** The Security Services providing agency shall not employ any person below the age of 21 years and above the age of 60 years.
- 2. The rate quoted shall be responsive and the same should be inclusive of all statutory obligations such as Minimum wages (Refer in the Bid), ESI, PF contributions, service charges, all kind of taxes etc. The offers of those prospective bidders which do not meet the statutory requirements of applicable minimum wages, ESI & PF are liable to be rejected.
- 3. The Agency shall comply with Contract Labour (R&A) Act, PF provisions, ESI provisions, etc. whichever applicable and all other statutory payments will be the liabilities of the SecurityServices Agency, applicable from time to time.
- 4. The Security personnel should be of sound Health and preferably having education up to 8th standard. Their character antecedents must be verified by the SecurityAgency and a proof thereof should be submitted to Principal Govt. Polytechnic for Women Jammu before their deployment.
- 5. The SecurityServices whose services are provided by the Agency will at all times and for all purposes, be the employees of the Agency who will be responsible for necessary service benefits to them. Principal Govt. Polytechnic for Women Jammu shall have the right for removal of a person of the Agency who is not discharging his duties satisfactorily or his role is found dubious in nature. They shall be informed meticulously that their engagement shall not confer any preferential right to be engaged by Govt.
- 6. The Agency shall not engage any sub-contractor or transfer the contract to any other person.
- 7. The approximate number of person required to be engaged will be **01 (One)** Security Personnel. However, Principal Govt. Polytechnic for Women Jammu has

the right to change the number of Personnel at his/her discretion at any time and the agency shall be bound to provide the amended numbers required.

- 8. Attendance of personnel will be maintained by the service Provider and copy of the same shall be provided along with the monthly bill to the office of the Principal Govt. Polytechnic for Women Jammu on the 1st working day of the following month.
- 9. On any given day, if any of contractor's personnel(s) deployed under the contract is (are) absent or fails to report in time, the contractor must provide a suitable substitute in time, for this purpose the contractor must monitor on a daily basis the sanction of leave to the staff deployed.
- 10. The administrative issues like leave, discipline etc., of the Security Personnel are responsibility of the contractor and if failed to comply above compliance the appropriate action will be taken.
- 11. The Agency shall deploy Security Personnel after medical examination at its own cost and medical certificate is to be submitted to the Principal Govt. Polytechnic for Women Jammu at the time of deployment.
- 12. The list containing the names, verified addresses, affixing a photograph along with the signature of each employee appointed by the Agency shall be made available to Principal Govt. Polytechnic for Women Jammu with their Bio-data before commencing the contract.
- 13. The changes in the personnel deployed will not be allowed without prior approval/permission of the Principal Govt. polytechnic for Women Jammu.
- 14. No enhancement in the agreed rates will be allowed during the Contract period except statutory revision if any.
- 15. The Agency will submit the proof of deposit of EPF and ESI within three weeks from the disbursement of wages every month, to the Principal Govt. Polytechnic for Women Jammu. Copy of the Challans vouchers in relation to ESI & EPF subscription deposit with the Bank should be submitted every month with certified copy of list of deployed SecurityPersonnel against whom the amount is deposited. Certified copy of returns submitted to the ESI & EPF authorities should be produced periodically.
- 16. The bill for each month shall be presented in triplicate by the Agency by 10th of every following month duly pre-receipted. The SecurityAgency will pay the wages to their workers latest by 7th of every month. Payment of wages shall be done through bank account only by electronic clearance system. The payment to workers is not linked with payment of bill by Institution.
- 17. The Performance security deposit shall be returned to the Agency on the expiry of the contract period on furnishing usual clearance/No Demand Certificate. The Security Deposit shall be returned on the expiry and termination of the Contract subject to conditions that the SecurityAgency has indemnified the 1st Party (Principal Govt. Polytechnic for Women Jammu) for all payments to the staff. The SecurityAgency while requesting for release of the Performance Security Deposit

shall certify that all payments including Labour Laws obligations have been fulfilled and that the Principal Govt. Polytechnic for Women Jammu shall not be responsible for such payments to the staff arising out of the decision of the Labour court, if any.

- 18. The Contract shall come into force from the date of Agreement signed by both the parties. In case the Agency fails to execute the job after signing the Agreement Deed or leave the job before completion of the period of Contract at their own accord, Principal Govt. Polytechnic for Women Jammu shall have the right to forfeit the Performance Security Money Deposited by the Agency for execution of the Contract.
- 19. The Agency shall comply with the Labour laws applicable and Principal Govt. Polytechnic for Women Jammu shall not be responsible for any litigation/default from Agency-side.
- 20. Principal Govt. Polytechnic for Women Jammu shall have the full powers to terminate the tender process at any stage, without assigning any reason. The decision of Principal Govt. Polytechnic for Women Jammu in this regard will be the final.

MANPOWER

- 1. Any misconduct / misbehavior on the part of the manpower deployed by the Contractor will not be tolerated and such person will have to be replaced by the Contractor at his own costs, risks and responsibilities immediately, with written intimation to Principal Govt. Polytechnic for Women Jammu
- 2. The contractor should ensure to maintain adequate number of manpower. In case the available manpower is less when compared to the required, a penalty of Rs.500/per day will be deducted from the bill.
- 3. The Contractors shall employ adult SecurityPersonnel only. Employment of child labour will lead to the termination of the contract. The contractor shall be responsible for payment by following the Minimum wages Act, ESI Act, PF Act, as applicable and also of obeying all existing Labour laws.

TERMINATION CLAUSE

During the period of agreement if it is found that the agency is not providing proper services or charging by fraudulent manner or otherwise, the whole security deposit, deposited with Principal Govt. Polytechnic for Women Jammu or part thereof shall be forfeited in favor of Principal Govt. Polytechnic for Women Jammu and agreement may be terminated as per tender terms and conditions.

ARBITRATION CLAUSE

It is mutually agreed that all difference and disputes arising out of or in connection with this Agreement shall be settled by mutual discussions and negotiations and if such disputes and differences cannot be settled and resolved by discussions and negotiations then the same shall be referred to the Sole Arbitrator appointed by Principal Govt. Polytechnic for Women Jammu, whose decision shall be final and binding on both the parties. The arbitration proceeding's shall be governed by Indian Arbitration and Conciliation Act 1996 as amended from time to time.

The cost of Arbitration shall be borne by the respective parties in equal proportions. During the pendency of the arbitration proceeding and currency of contract, the contractor shall not be entitled to suspend the work/service to which the dispute relates on account of the arbitration and payment to the contractor shall continue to be made in terms of the contract. Arbitration proceedings will be held at Jammu only.

The High Courts of J&K at Jammu shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

DUTIES, REESPONIBILITIES, JOB DESCRIPTION AND SCOPE OF WORK

- The Agency shall be responsible for overall Security within the Institution Campus on all days including Sundays and other holidays.
- 2. The security personnel should not leave the point unless and until the reliever comes for shift duties.
- 3. The Agency shall be responsible for overall security measures and arrangements to safeguard the movable and immovable property and prevention of theft within the Polytechnic Campus.
- 4. Controlling the Intrusion Prevention (IPs) /visitors to the Polytechnic.
- 5. Prevention of unauthorized entry of personnel including all types of outside vendors in the entire campus.
- 6. The vehicles that enter into the premises must be identified, noted in the Register and parked at designated places.
- 7. The Security personnel shall be deployed in One shift for 8 hours i.e. 9 a.m to 7 p.m.
- 8. The Agency shall provide proper uniform, whistle, baton for the day shift workers
- 9. The Agency shall be fully responsible for the performance and fitness on their duty of their Security Personnel.
- 10. The Agency shall have to maintain a round-the-clock Control Room with Telephone No., Mobile No., names of persons manning the Control room in their office in J&K for any urgent communication regarding any extra-ordinary situation.
- 11. The Agency shall have to provide the Mobile Phone Nos. of the SecurityPersonnel for records.
